# #TheWomblesEcoSchool Competition Terms and Conditions

#### **Promoter**

1.The competition promoter is Eco-Schools England, Keep Britain Tidy ("Promoter"). 2.The Promoter is registered at Keep Britain Tidy is a registered Charity No. 1071737. Registered as a company limited by guarantee in England & Wales No. 3496361. Registered office at Elizabeth House, The Pier, Wigan, WN3 4EX.

### **The Online Competition**

- 1. The online competition is open to individuals under the age of 17 from any country (the "Entrant") who have full parental/ guardian permission to take part.
- 2. Competition winners from each of the 3 categories will only be picked from entrants living in England.
- 3. The competition is not open to any employee (and their families) of the Promoter's group of companies, the supplier of any prize or any other companies associated with the competition.
- 4. All entries must be submitted for the competition before Friday 29th May 2020 at 16.00 (GMT). Any entries submitted after this time will not be accepted.
- 5.The Promoter will not accept entries which breach any laws in relation to content, include profanity or references which infringe the rights of third parties.
- 6. The Promoter will not accept entries that do not have full parental/guardian permission and follow the competition submission guidelines below
- Nursery (0-4 years): In order to be entered in the competition parents/ guardians will need to share a photo of the Entrants drawing on their Facebook, Twitter or Instagram accounts using the #TheWomblesEcoSchool. We advise no images of children in the photos however should a parent/guardian choose to do so, they must also to be included in the photo submitted as a competition entry. Failure to do so will mean that the entry is not valid. Any pre-schools/nurseries submitting entries should not include any images of the Entrant and they must also have permission from the Entrants parent/guardian to submit the entry. The Promoter does not accept any responsibility for obtaining parental consent on behalf of the preschool/nursery submitting.
- Primary (5-11 years): In order to be entered in the competition parents/guardians or schools will need to share a photo of the Entrants cartoon strip on their Facebook, Twitter or Instagram accounts using the #TheWomblesEcoSchool. These entries must not contain any images of the Entrants. Competition entries can either be submitted as one photo of all 5 of your cartoon panels or 5 separate photos of each cartoon panel.













Any schools submitting entries should not include any images of the Entrant and they must also have permission from the Entrants parent/ guardian to submit the entry. The Promoter does not accept any responsibility for obtaining parental consent on behalf of the school submitting.

- Secondary/ college (12-17 years): In to be entered in the competition parents/ guardians or school/ college will need to share the Entrants 30 second video clip on their Facebook, twitter or Instagram accounts using the #TheWomblesEcoSchool. If the Entrant is old enough to have their own social media account and have permission from their parents/ guardians then they may submit their 30 second video entry using their social media accounts. Any schools/ colleges submitting entries should have permission from the Entrants parent/ guardian to submit their 30 second video entry. The Promoter does not accept any responsibility for obtaining parental consent on behalf of the school/ college submitting. Any video submissions over 30 seconds will not be accepted as entries.
- 6. Entrants, their parents/guardians or educational setting submitting on their behalf must not engage in or be connected with any conduct that may bring the Promoter or any products into disrepute.
- 7.The Promoter will not accept responsibility for any entries that are late, lost, damaged, incomplete, fraudulent or not received due to technical conditions. Incomplete or duplicate entries will not be eligible. Proof of entry is not proof of receipt.
- 8. The Promoter reserves the right to reject any entries without reason or prior notice.

#### **Winner Selection**

- 1.The 3 winning Entrants (the "Winner") will be selected by the Promoter from all who meet the competition entry criteria above and have full parental/guardian consent to so do. If the Winner does not have full parental consent then a new Winner from that category will be picked.
- 2. The results of the competition are final and no correspondence will be entered into.

  3. The Winner will be notified by a representative from the Promoter via the social media account they used to submit the entry on behalf of the Entrant. This maybe a parents/ guardians personal account or a schools account. If a schools account then it is the responsibility of the schools to notify the Entrant and their parent/guardian.

  4. The Winner parents/guardians will have 5 working days to respond to initial
- notification confirming they wish to accept the prize. Failure to respond within the 5 working days will result in an alternative winner being selected and the prize will be awarded to a reserve winner selected in the same manner.

- 5. The nursery, school or college of the Winner will also have 5 working day to respond to initial confirmation that they will accept the £500 (five hundred pounds) donation and agree to arrange a school visit with the promoter at a date which is suitable for all parties involved. Parents/guardians of the winner will not be involved in this process.
- 6. The nursery, school or college has 3 weeks after notification of winning the £500 donation to notify the Promoter of which wildlife charity they would like their winning donation to be given to on their behalf. Parents/guardians of the Winners will not be allowed to make this decision.
- 5. You agree that the Promoter shall be entitled to reproduce, publish, exhibit, transmit and broadcast including in the media and use the Entrants first name only and nursery, school or college name to identify them in relation to publicizing the competition and you as the winner.

#### **Prize**

- 1. The 3 Winners schools will receive the opportunity for a visit from one of The Wombles to attend a nursery, school or college litter pick ('the Prize').
- 2. The Prize is subject to the availability of the Wombles on the date of the Winner's litter pick.
- 3. In the event the Wombles is not available on the date of the Winner's litter pick, the Promoter will, where possible, provide the Winner with available dates so that a suitable date can be arranged for the Wombles to attend the Winner's litter pick.
- 4. The Prize is also subject to the Winner and their parent/ guardian agreeing to participate in any press releases, photography and/or filming to celebrate the campaign. Any such press releases, photography or filming may be used by the Promoter for marketing purposes, including on social media.
- 5. The Prize is non-negotiable
- 6 The Prize is only open to entries living and attending nursery, school or college in England.

## General

- 1. By entering the competition, the Entrant's parents/ guardians agree and are bound by these terms and conditions.
- 2. The Promoter reserves the right to amend these terms at any time without notice and to communicate the changes to entrant's parents/ guardians by updating these terms on its website.
- 3. The Promoter shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control or amount to force majeure and shall be entitled to suspend or terminate the competition as a result.
- 4. Entrants parents/ guardians acknowledge that the competition is in no way sponsored, endorsed, administered by, or associated with any social media provider, and that you are providing information to the Promoter and not to any third party.
