

# **How Nature Helps The Harvest: Poetry Competition**

## **Competition Terms and Conditions**

### **Promoter**

- 1. The competition promoter is Eco-Schools England, Keep Britain Tidy ("Promoter").
- 2. The Promoter is registered at Keep Britain Tidy is a registered Charity No. 1071737. Registered as a company limited by guarantee in England & Wales No. 3496361. Registered office at Elizabeth House, The Pier, Wigan, WN3 4EX.

### The Competition

- 1. The 'How Nature Helps the Harvest' poetry competition is open to individuals under the age of 18 (the "Entrant") who have full parental/ guardian or school permission to take part.
- 2. The competition is not open to any employee (and their families) of the Promoter's group of companies, the supplier of any prize or any other companies associated with the competition.
- 3. All entries must be submitted for the competition before Friday 2nd October 2020 at 16.00 (GMT). Any entries submitted after this time will not be accepted.
- 4. The Promoter will not accept entries which breach any laws in relation to content, include profanity or references which infringe the rights of third parties.
- 5. The Promoter will not accept responsibility for any entries that are late or not received due to technical conditions.
- 6. Incomplete or duplicate entries will not be eligible. Proof of entry is not proof of receipt.
- 7. The Promoter reserves the right to reject any entries without reason or prior notice.
- 8. This competition is open to schools, individuals and home schoolers. Schools do not have to be a registered Eco-School to take part in the competition.

### **Winner Selection**

- 1. The winning Entrant (the "Winner") and will be announced live by JB Gill during the Harvest Festival LIVE event on Friday 9th October 2020, when their winning poem will be read out live. The Winner will not be notified before then The winning entrant (the "Winner") will be picked by the Eco-Schools England and Jordans Cereals team.
- 2. By entering the competition as the parent/ guardian or school of the Winner you agree that the Promoter, Jordans Cereals and The Wildlife Trusts shall be entitled to reproduce, publish, exhibit, transmit and broadcast including in the media and use the Entrants first name and area where their school (or home if home-schooled) is located.
- 3. The Winner will have met all the competition entry criteria above and have full parental/guardian or schools consent to so do. This will be indicated on the 'How Nature Helps the Harvest competition submission form.
- 4. The runner up entrants (the "Runners Up") will be picked by the Eco-Schools England and Jordans Cereals team.
- 5. The results of the competition are final and no correspondence will be entered into.
- 6. After the Harvest Festival LIVE event Eco-Schools England will contact the Winner and two Runners Up using the contact details provided on the 'How Nature Helps the Harvest' competition submission form to arrange delivery of their prizes.
- 7. The Winner parents/guardians or school will have 5 working days to respond to initial notification confirming they wish to accept the prize. Failure to respond within the 10 working days will result in an alternative winner being selected.

### Prize

- 1. The Prize is also subject to the Winner and their parent/ guardian and school agreeing to participate in any press releases, photography and/or filming to celebrate the campaign. Any such press releases, photography or filming may be used by the Promoter, Jordans Cereals and The Wildlife Trusts for marketing purposes, including on social media.
- 2. The Prize is non-negotiable

### General

- 1. By entering the competition, the Entrant's parents/ guardians and school agree and are bound by these terms and conditions.
- 2. The Promoter reserves the right to amend these terms at any time without notice and to communicate the changes to entrant's parents/ guardians by updating these terms on its website.
- 3. The Promoter shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control or amount to force majeure and shall be entitled to suspend or terminate the competition as a result.
