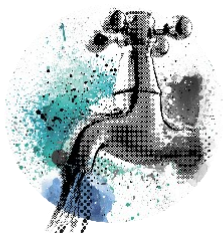

FAQs

What age range or key stage are these Eco-Schools training sessions aimed at?

Each of these training sessions are relevant for Eco-Coordination with pupils from Early Years Foundation Stage to Key Stage 5 with differentiated advice for all age groups.

I work in an SEN school, is this training relevant for me?

Yes, every school is different and these training courses address flexibility around the Eco-Schools criteria to ensure the Eco-Schools programme is suitable to all.

I am interested in the Eco-Schools programme, but not currently employed by an educational institution—can I register for the course?

Unfortunately not, these courses are designed to guide registered schools (or nurseries) to Eco-Schools Green Flag success, so are not available to individuals not employed by an educational institution.

Can I go complete more than one course?

Of course, but if you do want to complete multiple courses please check whether either of our training bundles offer you better value.

I wanted to work towards an Eco-Schools Green Flag this year, but I am worried about COVID-19 affecting our Eco-Schools work, do these training sessions address this?

Yes, for each of the Eco-Schools Seven Steps and Ten Topics covered in these courses advice is provided on how to adapt the programme in relation to COVID-19.

I want to participate in Eco-Schools training, but will be unable to attend the live Zoom meetings—can I still enroll?

Yes! We would really enjoy seeing as many Eco-Coordination as possible at this training event, but we understand that people may have other commitments. Even if you are unable to attend the zoom meetings you will still have access to bespoke training resources and ongoing one-on-one support.

I've never used Zoom before, is it hard to use?

No, we chose to use Zoom because it is simple to use, but if you do require support we will be happy to help.

I want to attend this course, but I am worried about the different deadlines for submitting evidence—what should I do?

The Eco-Schools team really like the idea of multiple teachers working towards and applying for an Eco-Schools Green Flag together, however, being former teachers we also understand that sometimes teaching (and life) gets in the way—if you are unable to meet the deadlines set that's fine and we will continue to support you on your Eco-Schools journey.

Will Eco-Schools be doing 'real-life' training courses in the future?

We hope to be able to deliver in-person sessions in 2021, but with the COVID-19 situation changing rapidly, and several of our training venues remaining closed, unfortunately we are unable to say definitive dates when we will deliver in-person training again.
